

#### About the Seminar

Marriage is the age old institution pregnant with the objective of legalization of love making and procreation of children. A married woman with a child is given more regard not only in her family but also in society. Infertility impotency or incapacity of any partner or of couple poses a serious hurdle in this regard. Here, Assisted Reproductive Technology (ART) and surrogacy arrangement comes as a surprising treatment and appealing supplement for such persons. Through ART the first test tube baby 'Louise Joy Brown' was born in Britain on July 25, 1978 and now she is also the mother of a child. The second was India's Durga alias Kamupriya Agarwal in Kolkata. These two incidents has set aside many controversies relating to ART. ART comes under the domain of medical science. It is not a treatment of infertility but helps the infertile couple to get a child. It is of two kinds-one in which the fertilisation of egg happens in-vitro (inside the woman's body) and the other in which all the process is done in-vitro. In-vitro fertilisation is a very complex method. It is a medical procedure for fertilizing human eggs outside a woman's body. This IVF and ART is the very basis of surrogacy arrangement. Surrogacy is a state or condition of being a surrogate. It is a practice in which a woman bears a child for a couple unable to produce children in usual way. The legal aspects relating to surrogacy are very complex. Many countries have drafted law to govern its various aspects. In India, till the date there is no specific law to govern the issues related to surrogacy. In 2005, ICMR and NAMS issued certain guidelines to check the use of ART but these are not binding. The Law Commission of India in the year 2009 sub-motus took the issues related to surrogacy for study and in its 228<sup>th</sup> Report recommended on its various aspects. Recently in India a draft of 'Assisted Reproductive Technology (Regulation) Bill and Rules 2013', has been prepared by fifteen member committee including experts from ICMR, Ministry of Health and by other specialists in the field. The Bill is ready to be passed by Parliament. If we analyse we find that many provisions of ART Bill need reconsideration. In surrogacy arrangement many unresolved moral and ethical issues are involved. An orthodox view is that it is highly immoral, unethical and inconsistent with human dignity that a woman uses her uterus for financial profit and treats it as an incubator for someone else child. This is high time to ponder over these issues and initiate sincere attempts in meeting them. This National Seminar aims to discuss medical, social, economic and ethical concerns of surrogacy as well as efficacy and efficiency of proposed Bill, so that healthy and happy measures may be recommended to concerned authorities and Govt. of India.
